### **SCHOLARSHIP FOR CLASS IX STUDENTS**

In continuation to notification No. F (C.Acad-NMMS)18, Dated: 16.08.2018, applications are invited on prescribed Application Performa from the class IX studying students of **Summer Zone Areas as well as Winter Zone Areas of Jammu Division (including Leh District of Ladakh Division)**, who have passed Class VIII in the year 2018-19, for the Centrally Sponsored National Means-cum-Merit Scholarship Scheme (NMMS), under which a student is entitled to receive Rs 1000.00 (Rupees One Thousand only) per month from classes 9<sup>th</sup> to 12<sup>th</sup>.

The Application forms circulated in the Government Schools through Director, School Education Jammu and concerned Chief Education Officers be submitted back in respective CEO offices by or before **24<sup>th</sup> September 2019**. The concerned Chief Education Officers' shall ensure the deposition of duly completed Application forms in the JKBOSE CDR Wing at Rehari Colony, Jammu latest by **25<sup>th</sup> September, 2019 through Special messenger**. The application forms shall be duly attested by the concerned Head of the Institution and accompanied by the requisite certificates (Qualification certificate, Income Certificate & Reserved Category Certificate, if any), and Examination Fee amounting to Rs 60/- through Pay-in Slip (From J&K Bank) be deposited in JK Bank A/C No. 0547010100000002, Branch JKBOSE Bemina, Srinagar, IFSC Code JAKAOEXAMBR in favour of Liaison Officer NTSE/NMMS.

#### **The Eligibility Criteria for Special NMMS Examination:**

1. The student must be studying in the class 9<sup>th</sup> presently in Government Schools/Government aided schools.
2. The student must have minimum of 55% marks in class VII & class VIII (5% relaxation for SC, ST & OBC students).
3. The overall family income should not exceed Rs 1.5 Lakh per annum.
4. The student must continue his/her studies in Government School up to Class 12<sup>th</sup>.
5. The complete filled application form should be accompanied with 7<sup>th</sup> & 8<sup>th</sup> Class marks certificate, Income Certificate & Category Certificate (if any).


